## The Brooklyn Healthcare Improvement Project

### **Project Overview**

The New York State Department of Health awarded the HEAL NY 9 grant to SUNY Downstate Medical Center for the following goals:

- 1. Development of a comprehensive community health planning process with diversified stakeholders to articulate the vision for health care in the communities of Central and Northern Brooklyn and how that vision is accomplished;
- 2. Study of issues influencing emergency department service overuse.
- 3. Collection of relevant data from public sources and proprietary claims information from insurers and hospitals to analyze primary care service model/ capacity/availability/utilization, in Brooklyn neighborhoods with high rates of ambulatory care sensitive hospital admissions (ASC).
- 4. Development of a dynamic, cutting edge information reservoir which can be continuously refreshed for future planning needs.

The grant, titled the Brooklyn Healthcare Improvement Project or B-HIP is scheduled to be completed by February 28 2011.

In collaboration with our partners from different sectors, B-HIP seeks to develop a comprehensive health resources inventory in Central and Northern Brooklyn, collect and analyze relevant data from various sources, and develop a comprehensive community health planning body. Once we completed data collection and developed this unique inventory, we will work with the health planning body on what recommendations to make that will shape practices and policies on health services use, improving health outcomes, and curbing costs. The data collection and resource inventory will be developed with three separate but linked approaches.

First, an analytic approach:

- Data review of emergency service utilization at the six participating hospitals, including interviews with providers and patients
- Collecting relevant data from public sources and proprietary claims information from insurers and hospitals to analyze primary care patterns including capacity, availability and utilization.

Secondly is a canvassing approach:

- Teams of 2 to 3 individuals will canvass the neighborhoods of Central and Northern Brooklyn identifying provider locations.
- Once identified, information will be gathered regarding services offered, service utilization, languages spoken, hours of operation, insurance and charity care policies, educational and professional qualifications, linkages with other facilities, etc.

Third a technological approach:

• All information gathered will be translated into a map creating a innovative Geographic Information System (GIS) forming the health resources inventory that can be used by all stakeholders for research and health planning needs.

Within the next month Dr. Howard Berliner, Ms. Dorothy Fyfe, and/or Ms. Priya Pasram will begin contacting and meeting with the various community partners for the purposes of discussing the project implementation and expectations and forming a more comprehensive insight into the services and resources offered by our community partners.
